## DESCRIPTIONS

**Lot Number:** The number mentioned on the labels on the column bag is the lot production number.

**Expiration of Certification:** The expiration date displayed in the first page means that the certification of the column set is valid, until the expiration date, provided the column set is stored in accordance with instructions given in this certificate (see “Instructions for Stability, Storage, and Use”). The certification is nullified if the column set is damaged, contaminated, or otherwise modified.

**Blank Level Values:** Blank level values, expressed as mass fractions (pg-TEQ per a column set), for selected PCB congeners, PCDD, and PCDF congeners are provided in Table 2. Blank level values are a reference value for which MIURA has the highest confidence in its accuracy, in that all known or suspected sources of bias have been investigated or taken into account (JIS K0311 or JIS K0312).

**Recovery Values (Blank & Sample):** Recovery values, expressed as percentages, are provided in Table 3 for selected mass labeled-PCB congeners, and selected mass labeled PCDD and PCDF congeners, based on selected mass labeled recovery standards added before GC-MS measurement. Recovery values meet EU regulations; however, the values meet the MIURA criteria for this certification, which are stricter than what is required by EU regulations.

### INSTRUCTIONS FOR STABILITY, STORAGE, AND USE

**Stability and Storage:** The column set should be stored at room temperatures below 25 °C until use. It should not be frozen or exposed to sunlight or ultraviolet radiation. After removing from the bags, the contents should be used immediately, especially, because the concentration column (lower) “Alumina” can be deactivated under high-humidity. Storing of the removed column set is not recommended.

**Use:** If storing in a cold room or refrigerator, bring to room temperature (let stand for approximately 30 min), remove water condensed on the surface of the bags. Carefully remove the bags to avoid damage of the column. Use the same lot number with one column set. For more information of column set refer to the GO-HT operation manual.

### ANALYTICAL METHODS USED AT MIURA

For preparation of blank level & recovery test, several column sets chosen at random per lot production were allowed to reach ambient temperature; two types of the purification columns (upper: silver nitrate silica gel, and lower: sulfuric acid silica gel) were assembled, and 10 mL of n-hexane was added to wet the top of the column with the designated column cap and disposable syringe. Then, a known amount of internal standard solution (containing selected labeled PCB, PCDDs, and PCDFs congeners; as shown in Table 1) dissolved in 2 mL of n-hexane was added to the top of the column with disposable syringe, and the syringe was washed with 2x2 mL of n-hexane; the n-hexane was injected into the column again. Then, the purification columns assembled with the concentration columns (upper) and (lower) were set to the each system unit immediately. After two fractions (dioxin and PCB fractions) were obtained from each system unit, a known amount of the recovery standard solution was added to each concentration vessel. Finally, both fractions were concentrated using an evaporation system under nitrogen to 0.01 mL.

The concentrated dioxin fraction was analyzed using gas chromatography/high resolution mass spectrometry (GC/HRMS JMS-800D, JEOL) operated in electron impact (EI) mode. A 0.25 mm ID × 60 m fused silica capillary (BPX-DXN, SGE) with 1.4 μm phase thickness was used. The concentrated PCB fraction was analyzed using GC/HRMS (JMS-700D, JEOL) operated in EI mode. A 0.25 mm ID × 60 m fused silica capillary (RH-12ms, INVENTX) was used. All injections were 2 μL using a splitless inlet. The results are provided in Table 2 and Table 3. The chromatograms of each compounds are shown at page 6 and after. Furthermore, the dioxin and PCB fractions were analyzed using gas chromatography/low resolution mass spectrometry operated in total ion scan (m/z 50 to 500) mode, to confirm if interferences may affect determination of target compounds by GC/HRMS are included in the fractions, the chromatograms are not shown here.

For the recovery test (sample), 3 g of sunflower seed oil from *Helianthus annuus* (S5007-1L, Sigma-Aldrich) was dissolved in 2 mL of n-hexane. A known amount of the internal standard solution was added to the flask, mixed, and allowed to equilibrate. First, several column sets chosen at random per lot production were allowed to reach ambient temperature; the purification columns (upper) and (lower) were assembled. 10 mL of n-hexane was added to wet the top of the column with the designated column cap and disposable syringe. Then, the sample with the internal standard was injected into the top of the column with the disposable syringe, and the syringe was washed with 2x2 mL of n-hexane; the n-hexane was injected into the column again. The purification column was assembled with the concentration column (upper) and (lower), and set to the each system unit immediately. After obtaining two fractions from the system unit, the dioxin and PCB fractions were concentrated using an evaporation system under nitrogen to approximately 0.01 mL. After the addition of a known amount of recovery standard solution, the both fractions were concentrated to 0.02 mL; then dioxin and PCB in each fractions were analyzed using GC/HRMS as mentioned above test. The inspection results is displayed in Table 3.
